Per our conversations regarding the Monterey Broadband Grant Agreement, Fiber Connect is submitting a general easement request for the roads of Beartown Mountain Road and Royal Hemlock Road. The purpose of this request is to assure Fiber Connect has an option to set new poles or trench new conduit for the purpose of bringing distribution fiber optic infrastructure past all premises along said roadways in the event the existing utility routes become cost prohibitive to upgrade to accommodate such infrastructure.

Fiber Connect will apply to the current pole owners along said roadways to utilize all or as much of the existing utility poles. If Fiber Connect deems it more economical to work around one or more existing poles Fiber Connect will exercise these easements. Fiber Connect will submit drawings as needed of new pole placements or conduits for recording with the town once completed. Fiber Connect will also work with the Director of Operations and the Tree Warden to optimize placement of new poles or conduits for the benefit of all parties.

Fiber Connect looks forward to completing this easement process, completing the agreement with the MBI, and reaching the 51% goal so we may move forward with completing the broadband project.

In the Spring Fiber Connect would also like to work with the Director of Operations to discuss the potential for extending the utility infrastructure South on River Road and Corashire Road to the New Marlborough border.
