Conduit shall be of no more than three (3) inch diameter CPVC or HDPE, and shall be affixed along the backside of the existing continuous wood guardrail posts running between Brett Road to the East and Stevens Lake Road to the West along the southern edge of Route 23 / Main Road.

Wherefore it prays that after due notice and hearing as provided by law, it be granted a location for and permission to erect and maintain poles and cables, together with such sustaining and protecting fixtures as it may find necessary.

FIBER CONNECT requests permission to locate poles, cable, and fixtures, including the necessary sustaining and protecting fixtures, along and across the following public way:

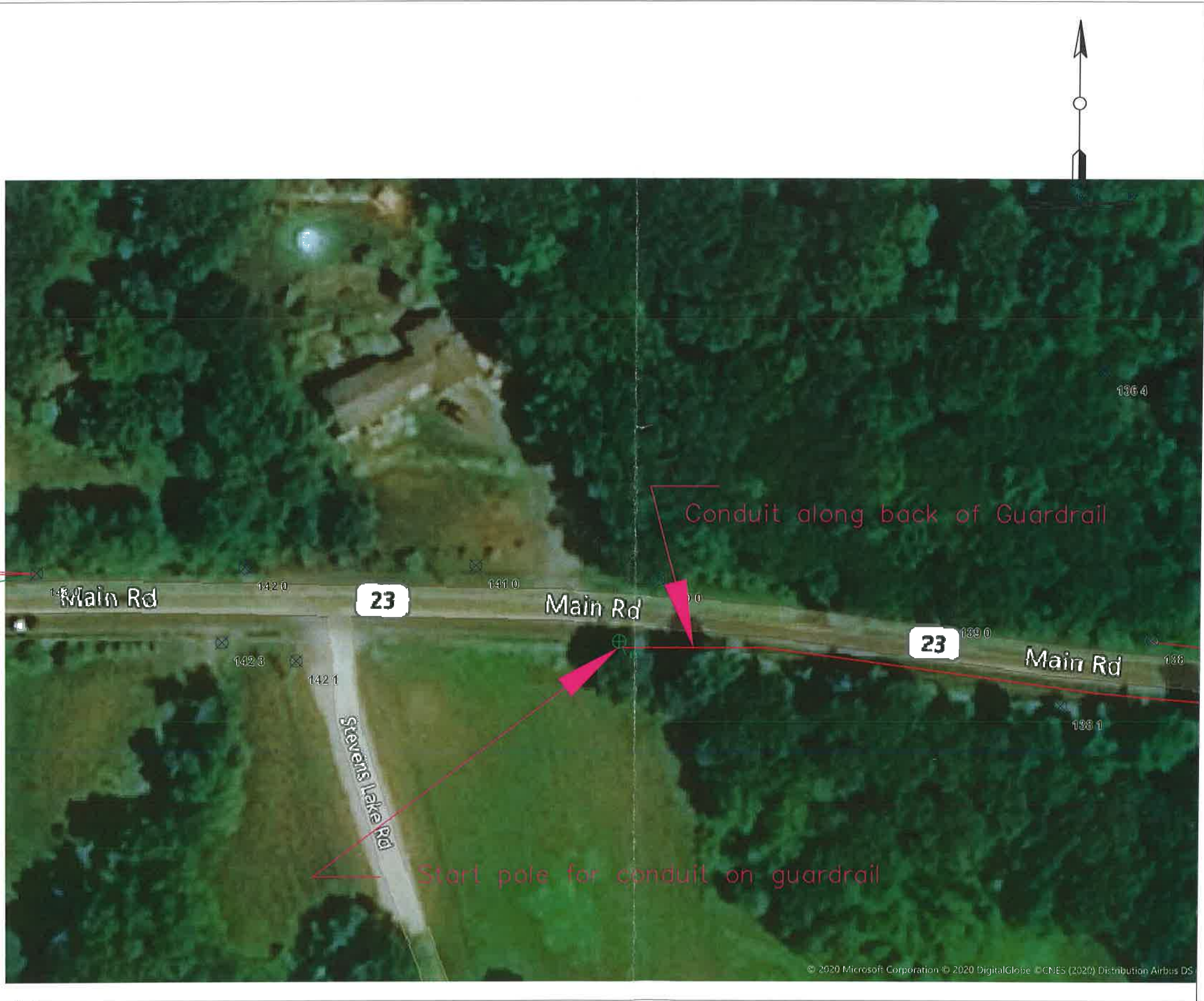

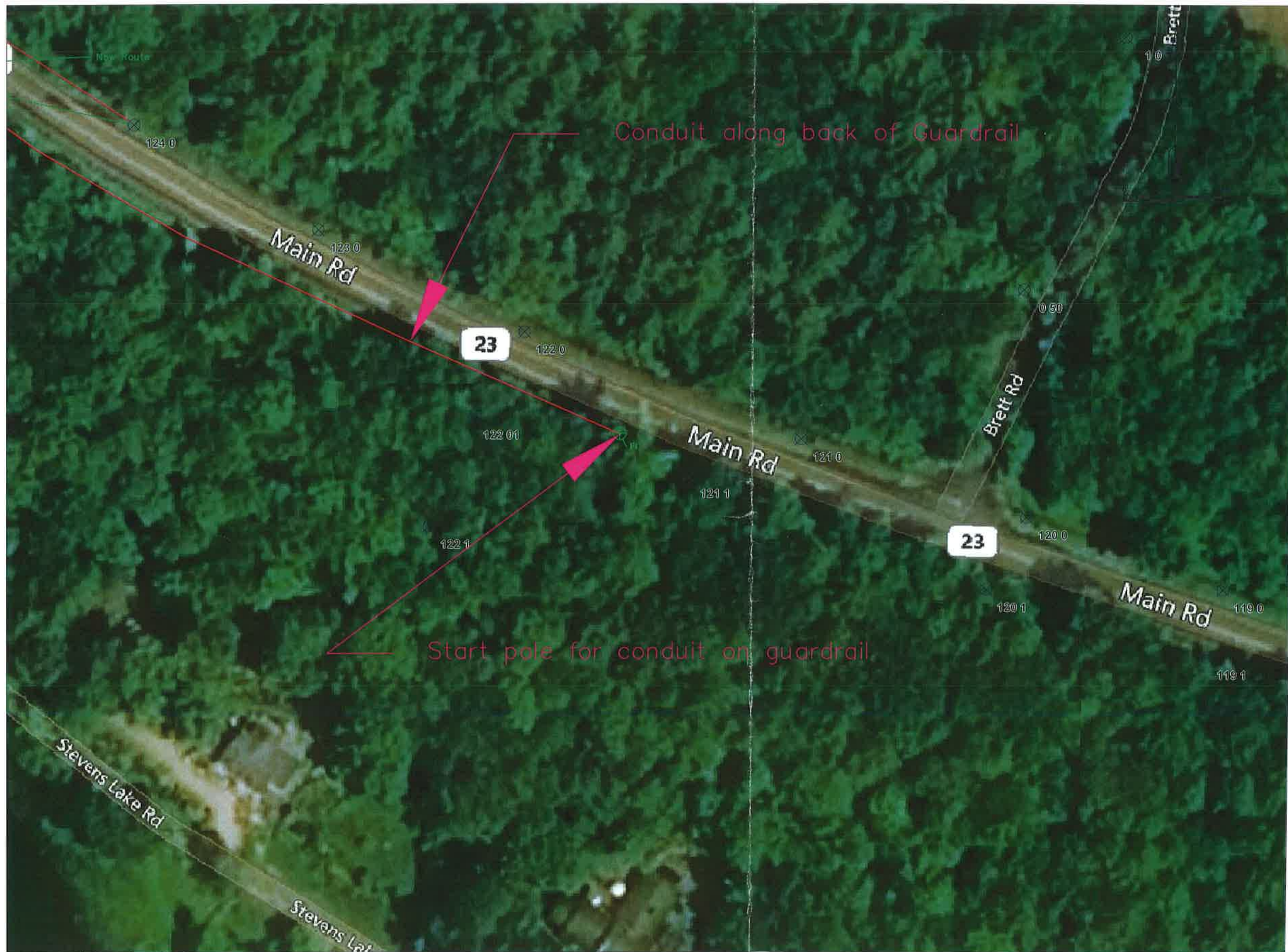

PETITION FOR TELECOM SHELTER and CONDUIT LOCATIONS

To the Monterey Board of Selectmen

FIBER CONNECT requests permission to locate poles, cable, and fixtures, including the necessary sustaining and protecting fixtures, along and across the following public way:

Fox Hill Road – Fiber Connect is installing one Aluminum telecom shelter of dimensions 16.5'x5.5'x8.5' (LxWxH), 90.75 sq/ft on a cement pad of dimensions 21.5'x5.5'. Requesting location of pad 15' back from each property line located at the Southwest corner of a 10.7 acre municipal parcel 108-034-000-000 on Fox Hill Road with approximate GPS coordinates of 42.18013, -73.21704.

Two conduits from said pad to utility pole 3 on Fox Hill Road to be buried across and along Fox Hill Road for the purpose of supplying power and communications cable to and from the telecom shelter.

Wherefore it prays that after due notice and hearing as provided by law, it be granted a location for and permission to erect and maintain poles and cables, together with such sustaining and protecting fixtures as it may find necessary, said poles to be erected substantially in accordance with the plan filed herewith marked – MNTRYP-HE2.
