Dear Select Board,

As you are aware, on May 25, 2022, I placed the Town on formal notice, via counsel, of my intention to pursue a Massachusetts Whistleblower claim pursuant to M.G.L.C. 149 sec. 185 against the Town. I subsequently filed a lawsuit in Federal Court against the Town and Melissa Noe for retaliating against me for exercising my rights of free speech as a citizen and by reporting, objecting to, and filing complaints about what I reasonably believed to be ongoing violations of law in the Town of Monterey and the Monterey Board of Selectman, specifically by Defendant Melissa Noe.

On September 14, 2022, the Berkshire Eagle published a news article regarding my complaint titled "Monterey's clerk files a whistleblower lawsuit against the town and its officials, citing a hostile workplace." The following day, September 15, 2022, Select Board member Susan Cooper retaliated against me by drafting correspondence highlighting what she perceived to be six (6) previous violations of previous misconduct by myself. Many of the stale 'issues' raised by Cooper dated back months' prior to the filing of the initial complaint and were only brought forward after I filed a lawsuit.

Ms. Cooper threatened me that my alleged misconduct may lead to discipline, up to and including termination. Cooper's threat of termination was yet another example of the retaliation I continue to experience as a result of her exercising her right to raise significant concerns and complaints about the ongoing misconduct by Town officials.

Incredibly, after I repudiated Cooper's efforts to discipline or terminate me for these six 'issues,' Cooper authored another letter two days later, on September 23, 2022. Once again, in her September 23, 2022, letter, Cooper threatened to discipline and terminate me for an additional four (4) issues that were not raised during the first executive session. These 'issues' once again dated back months prior and were raised only after I filed my complaint.

Additionally, subsequent to the aforementioned Select Board hearings, my work conditions have been changed to now require me to submit a "Town Clerk Weekly Status Report" wherein I am required to stipulate the hours I worked and on which duty or responsibility I hold. This requirement was never in place prior to the filing of my complaint and was only done as a means to further harass me. I feel I was targeted and each weekly sheet I filled out I was criticized, harassed and intimidated by both Melissa Noe and Susan Cooper. Susan Cooper intimidated me at a Board of Selectmen's meeting stating my hours for working on projects were inaccurate and she could do the job faster.

Subsequent to the filing of my complaint, the Town and its agents, have initiated the practice of taking my personal salary funds to pay other employees on days when I am unable to

work due for personal reasons or due to illness. This practice was not in place prior to the filing of my complaint and was done solely to retaliate against me. No other employee of the Town is subjected to the same salary docking.

Due to constructive discharge tactics used regularly by Select Board member Susan Cooper and Town Administrator Melissa Noe, I am forced to resign my position with the Town. The conditions created by Cooper and Noe have become so unbearable that I am unable to execute my duties and I also fear for my physical safety.

Over the past several months, I have used the proper human resources channels to indicate the abuse and harassment that was taking place in my department. At that point, I had warned of repeated instances of retaliation, but it appears that my words fell on deaf ears.

I was told by residents that the Select board was planning to fire me as soon as the State Election was over and they wouldn't need me anymore. Even though I suspected termination, I worked 20 hours on Election Day and 12 hours the day after the election. The election ran smoothly and I made sure all voters were able to vote and all the ballots were submitted to Elections in Boston before I went home at 2:00 a.m. on Wednesday morning. One gentleman came to my office and told me I should resign before I was fired. He said it's your choice but it would be better to resign than get fired. He said, "Make the right choice."

I am extremely disappointed in the lack of responsibility shown by the Town and the lack of remedial action on my behalf. I enjoyed my job and I love the people of Monterey. I have always wanted to serve the needs of such a wonderful community. However, the hostility and harassment I have been forced to endure on a daily basis without any indication that there will be corrective action taken against those causing such harm has left me with no choice but to resign effective November 30, 2022.

It is my understanding that Monterey has not adopted a consolidated department of municipal inspections pursuant to MGL Part I, Title VII, Chapter 43C, Section 13.
Each of our Inspectors (Building Commissioner, Inspector of Wires, and Inspector of Plumbing/Gas) has at least one assistant/alternate who completes inspections when the Inspector has a conflict of interest or is otherwise unable to complete the inspections.
The Town's Building Commissioner also serves as the Zoning Enforcement Officer and is the only of the three position who is paid an hourly rate rather than a per inspection fee. The Building Commissioner has in some ways become the de facto "Department Head," although it seems that if we do not have a consolidated department, each inspector works as his own department.

Hi Chief -

The non-civil service probationary period is set forth in G.L. c. 41, section 133. It provides as follows:

Section 133. Pursuant to this chapter, and notwithstanding the provisions of any general or special law to the contrary, the appointment and reappointment of full-time police officers not subject to the provisions of chapter thirty-one shall be subject to the following provisions:

- (a) The initial appointment shall be for a period of one year during which a person shall actually perform the duties of such position on a full-time basis. The initial appointment shall be a probationary period during which police officers shall be deemed employees at will whose removal or dismissal shall be without recourse at any time during such initial appointment.
- (b) Appointment subsequent to the initial appointment shall be made annually or for a term of years as the appointing authority shall determine, or for an unspecified or indefinite term of appointment as long as the officer is not removed as described in this paragraph. The appointing authority may remove any such officer for cause, or for some other standard contained in an applicable collective bargaining agreement or employment contract, and after a hearing, at any time during such appointment. For police officers covered by collective bargaining agreements or employment contracts which contain standards for the discharge, termination or removal of employees, the non-reappointment of a police officer serving under an appointment subsequent to an initial appointment shall be considered to be a discharge, termination or removal and the standards shall be enforceable with respect to such non-reappointment by the procedures set forth in the collective bargaining agreement or employment contract.
