SUBJ:

Contacting Town Counsel

Whereas, the Town of Monterey through its Select Board directs and supervises the use of Town Counsel;

Whereas, the Select Board intends to identify appropriate use of Town Counsel's time with an appropriate protocol;

The Select Board hereby adopts the following policy:

- 1. The Chair of the Select Board shall act as the liaison to Town Counsel.
- 2. If the Chair of the Select Board must recuse himself on a matter due to conflict of interest, the alternate Chair shall act as liaison to Town Counsel for that matter. If the Chair fails to fulfill the responsibilities laid out in this policy, or if the Chair does not authorize a confidential or time sensitive request for access to Town Counsel, the requestor of access to Town Counsel shall have the ability to make an appeal to the entire Select Board about the matter.
- 3. Department heads and chairs of multimember bodies may request authorization to contact Town Counsel for matters not requiring confidentiality by presenting the same in writing to the Select Board for its approval at its next meeting. Only department heads and Chairs of boards, committees, and commissions may request to contact Town Counsel. Regarding questions from Town multimember bodies, unless a matter requires confidentiality, a majority of the body shall, prior to bringing the issue to the Select Board, approve the question in open session, except in instances of (i) time sensitive nature, or (ii) when it would not be timely or practicable to convene the full body of a board, committee or commission, in which instances the Chair of said board, committee and commission may independently bring the issue to the Select Board.
- 4. For matters that are of an time sensitive nature, the Chair of the Select Board, as liaison to Town Counsel, shall be authorized to approve access to Town Counsel.

- If the Chair authorizes such action, the Chair shall notify the Select Board of the same at its next meeting.
- 5. For matters that would require the advice of Town Counsel to be requested and/or provided in confidence, the Chair of the Select Board, as liaison to Town Counsel, shall be authorized to approve access to Town Counsel. * If the Chair authorizes such action, the Chair shall notify the Select Board of the same at its next meeting. The Chair shall maintain confidentiality of confidential requests to contact counsel. If the question was asked in confidence and would be subject to the attorney-client privilege, the Chair shall simply inform the Board that a request to contact Counsel was approved. *The Building Commissioner shall be exempt from this provision providing he notifies the Board subsequent/4.
- 6. To the extent that a Town government body or official requires additional contact with or advice of Counsel in connection with an approved matter or a matter incidental and related thereto, no further Select Board approval shall be required. Notwithstanding the provisions of the prior sentence, however, the Select Board Chair shall be notified of any additional contact with Town Counsel and shall be copied on any written correspondence to or from Counsel, whether formal or informal. The Select Board, at its discretion, and only as necessary or appropriate, may authorize contact with Town Counsel concerning matters outside the requesting board or official's jurisdiction, and/or may authorize the Chair of the Select Board to approve the same. To the extent appropriate the Select Board Chair shall cause notice to be sent to the board with respect to which the question is being asked.
- 7. Only the Select Board may authorize use of special counsel.
- 8. Confidential legal advice sought or received by Town government bodies or officials should only be discussed in open session if absolutely necessary, understanding that such action will likely void the protections of the attorney client privilege. Likewise, the Select Board or any government body or official authorized to seek advice from Town Counsel, may only meet in executive session to discuss such matters as permitted by the Open Meeting Law and in strict compliance therewith.
- 9. Town Counsel has been instructed to forward any requests for legal services to the Chair of the Select Board to ensure that Counsel is properly authorized to reply. If not authorized to reply, the Chair will notify the requester and Town Counsel of the same.
- 10. Town Counsel may not respond directly to any legal inquiries other than as set forth herein.

Dear Selectboard,

As the Zoning Enforcement Officer I have been asked in confidence that a question be answered without me bringing the question and property location to light.

An example would be a real estate transaction that may occur pending my answer to a zoning question. If the transaction were made public, the deal may fall through for various reasons.

A Zoning enforcement action on my part may also be discussed with council but with the requirement for prior approval it may become unnecessarily public. I prefer to discuss an enforcement issue with the individual first to see if a correction and compliance can be achieved. The possibility of it being made public forces me to issuing a written violation notice.

Another example is responding to a hoarding complaint and the safety of the individual who occupies the premises. I would consult with council to review that the process is conducted legally. Contacting the chair for permission to speak to council, and then having the possibility of it becoming public would not be neighborly.

I have other examples but feel if the Building Commissioner has a question that requires a review from council on any zoning or legal issue, they should be able to use council without prior permissions. We are certified individuals, requiring much training and education. I believe the building official should be able to use their own discretion when contacting council.

I would be happy to discuss this issue and the policy you are creating for contacting council at your convenience.

Dear Steve,

When the question of forming a committee to investigate the establishment of a charter for the town of Monterey came to the floor at last June's Town Meeting, I had no idea what was at stake. It came to light during the discussion that followed and as time moved forward that we are questioning whether Monterey should change its form of direct government. That's some serious business. That is not something that should be taken lightly.

It should be understood by all that times are changing. To put it briefly, there are many more regulations and laws that must be followed by each town. These change all the time. There is almost no way that a part-time Select Board member can be up to date on all of these. There is a need for a trained professional to guide the Select Board through this maze. How much power and control should be granted to the professional? Is the professional a hired employee or an elected official? How much control will be taken from the individual Select Board member, who is elected by and responsible to the townspeople? What changes would be made to the various boards and committees whose job it is to oversee many facets of our government? And how much control of government will be taken from the public, who heretofore have had a major control of their government through Town Meeting? As I see it these are some of the questions that must be answered by the Charter Committee. But then I don't know a lot about charters and I could be way off base. Which is why I asked to join the committee. To learn and to help guide our town.

I was appointed to the Charter Committee on November 4, 2021. I took my oath on November 13th.

At this time Monterey is going through period where the environment is very hostile, to say the least. There is bullying and harassment involving employees, officials and members of the public. The level of animosity is incredible. An investigation has been approved and funded by Town Meeting. Hopefully this will take place in the near future and we can get back to operating at a normal level with decency prevailing.

In the meantime, some of the bullies, harassers and mud-slingers have now applied for positions on the Charter Committee. This is surely not the place for political, partisan haranguing. I reached out to several townspeople who I felt would make good, serious, thoughtful members for this committee. No one wanted to work with any of those involved in the current controversy, and so declined.

Therefore, I am asking that the Select Board temporarily suspend the Charter Committee. We've gotten along without a Charter for a long time. Better that we wait until serious allegations and issues have been resolved, then we throw our whole form of government into the boiling pot that currently exists.

If the Board decides that in order to suspend the establishment of the committee, they would require those who have already been appointed and sworn in step down so the whole process can start afresh in the future, I for one, for the sake of Monterey, would do so.

I sincerely hope that the Select Board will take my concerns to heart and seriously consider suspending forming a Charter Committee at this time.





I would like to apply for appointment to the Monterey Renewable Energy Working Group. I strongly support the idea of optimizing the construction and use of renewable energy in Monterey on both a private and municipal level at appropriate locations in town.

I'd like to offer assistance to the committee that will be addressing whether Monterey should have a town charter.

Creating a charter is much like creating a constitution, and I've spent many hours researching the process and considering how it is best done both in relation to the U. S. Constitution and the 1947 New Jersey Constitution.

Having served for three years as a town councilman in Livingston, N.J., for one year on the Monterey Planning Board, and for three years as a Monterey Selectman, I am fully familiar with our bylaws and the ways in which some of them can be improved.

Recently I've spent time studying town charter creation in Massachusetts. I understand most of the advantages and disadvantages of committing a town to the charter development process. Since this committee's charge is to decide whether or not to recommend that the town commit to engaging in such a process, and if so, which of the two routes available to follow, it would seem that my information might be useful to other committee members and to the town meeting.

During my 36 years as a judge, I've often been involved in constitutional, statutory, and local bylaw interpretation. That experience might prove useful in these circumstances.

On November 17, 2021 at 5:14pm (1 minute prior to a series of previously scheduled Selectboard Meetings, both in Executive Session and in Public Session- Agenda enclosed), John F. Weingold, Esq. Selectboard Member sent an email (copy enclosed) to the 2 other Selectboard Members, myself and Justin Makuc. This email was an INTENTIONAL VIOLATION of the Open Meeting Law, as it was clearly a DELIBERATION to a quorum of Selectboard. DELIBERATION COUNT 1: In the 1st sentence of the email, John F. Weingold, Esq. Selectboard Member makes a statement to the Selectboard about his 'boycott' and self-determined act of 'civil dis-obedience' IF Steve Weisz remains Chair of the Selectboard. This is clearly his OPINION and a violation of the OML. DELIBERATION COUNT 2: In the 2nd sentence of the email, John F. Weingold, Esq. Selectboard Member makes several statements about Steve Weisz's actions that begin with "My Perspectives are many". This is clearly his OPINION and a violation of the OML, DELIBERATION COUNT 3: In the 3nd sentence of the email, John F. Weingold, Esq. Selectboard Member demands that "open mics" not be used during Selectboard deliberations. This is clearly his OPINION and a violation of the OML. DELIBERATION COUNT 4: In the 4th sentence of the email, John F. Weingold, Esq. Selectboard Member gives his rational for the barring of "open mics" with the words that begin with "My perspective...". This is clearly his OPINION and a violation of the OML. (This is also the paragraph that refers to the Public as "dunderheads"). DELIBERATION COUNT 5: In the 5th sentence of the email, John F. Weingold, Esq. Selectboard Member begins with "From my Perspective the Chair and TA...". This is clearly his OPINION and a violation of the OML. DELIBERATION COUNT 6: In the last sentence of the email, John F. Weingold, Esq. Selectboard Member makes a final statement "We are not functioning as a board". While I agree with him, this is clearly a statement of OPINION and a violation of the OML. Lastly, it is important to note that on 10-17-2021 John F. Weingold, Esq. Selectboard Member filed an Open Meeting Law complaint. In the "What action do you want the public body to take in response to your complaint?" section, Mr. Weingold demands that the Selectboard "Stop conducting SB business via email." (copy enclosed). This clearly demonstrates that Mr. Weingold understands the OPEN MEETING LAW, demands that others follow the OPEN MEETING LAW, however he does not feel that the OPEN MEETING LAW applies to him.


